### 1. Scope

N1 Solutions is committed to maintaining the accuracy, confidentiality, and security of your personally identifiable information ("Personal Information"). As part of this commitment, our privacy policy governs our actions as they relate to the collection, use and disclosure of Personal Information.

This policy is designed to inform all employees, customers, stakeholders and business partners of N1 Solution's commitment and recognition to our obligation under legislation.

#### What is Personal Information?

Personal Information includes name, address, phone number, e-mail address and any other information that will identify an individual.

### 2. Identifying Purposes

N1 Solutions collects, use and disclose Personal Information to provide you with the product or service you have requested and to offer you additional products and services we believe you might be interested in. The purposes for which we collect Personal Information will be identified before or at the time we collect the information. In certain circumstances, the purposes for which information is collected may be clear, and consent may be implied, such as where your name, address and payment information are provided as part of the order process.

### 3. Procedure

Our privacy policy is based upon the values set by the Canadian Standards Association's Model Code for the Protection of Personal Information and Canada's Personal Information Protection and Electronic Documents Act, (PIPEDA). This Act is designated to protect personal information that is collected during the course of a commercial activity.

We are responsible for maintaining and protecting the Personal Information under our control. All personal information that is collected by N1 Solutions is kept in a secure location and remains strictly confidential. We recognize the importance of complete confidentiality when dealing with stakeholders and strive to operate under such beliefs.

### 4. Consent

Knowledge and consent are required for the collection, use or disclosure of Personal Information except where required or permitted by law. Providing N1 Solutions with your Personal Information is always your choice. However, your decision not to provide certain information may limit our ability to provide you with our products, services or the capability to answer your inquiry in the appropriate manner. We will not require you to consent to the collection, use, or disclosure of information as a condition to the supply of a product or service, except as required to be able to supply the product or service.

### 5. Limiting Collection

The Personal Information collected will be limited to those details necessary for the purposes identified by N1 Solutions. With your consent, we may collect Personal Information from you in person, over the telephone or by corresponding with you via mail, fax, or the Internet.

### 6. Limiting Use, Disclosure and Retention

Personal Information may only be used or disclosed for the purpose for which it was collected unless you have otherwise consented, or when it is required or permitted by law. Personal Information will only be retained for the period of time required to fulfill the purpose for which we collected it or as may be required by law.

## 7. Accuracy

Personal Information will be maintained in as accurate, complete and up-to-date form as is necessary to fulfill the purposes for which it is to be used.

## 8. Safeguarding Customer Information

Personal Information will be protected by security safeguards that are appropriate to the sensitivity level of the information. N1 Solutions takes all reasonable precautions to protect your Personal Information from any loss or unauthorized use, access, or disclosure.

## 9. Openness

We will make information available to you about our policies and practices with respect to the management of your Personal Information.

## 10. Customer Access

Upon request, you will be informed of the existence, use and disclosure of your Personal Information, and will be given access to it. You may verify the accuracy and completeness of your Personal Information, and may request that it be amended, if appropriate. However, in certain circumstances permitted by law, we will not disclose certain information to you. For example, we may not disclose information relating to you if other individuals are referenced or if there are legal, security or commercial proprietary restrictions.
